Use this checklist to help assess whether or not a proposal will contribute to a healthy & sustainable community. Not every plan will incorporate all the elements listed below. But, a preponderance of 'no' responses indicates that a plan needs significant work before it can be considered to be of real & long-lasting benefit to your community.

Does the plan include housing for low-income people, people with disabilities & other sectors?				
Will wildlife & wildlife habitats be safeguarded &/or enhanced?				
Does the plan demonstrate consideration of alternative forms of energy, e.g., wind, solar, geothermal?				
Does the plan speak to the local setting, i.e., is there anything to indicate that the plan has been developed with awareness of local history, ecology, economy, adjacent land uses & other factors?				
Does the plan require significant amendments to the community's Official Community Plan or other related documents?

Have any opportunities been taken to incorporate the use of renewable energy sources (e.g., wind, solar, geothermal)?			
Does the plan reduce waste production & encourage waste re-use & recycling?			
Does it preserve natural systems, e.g., wetlands, streams, ravines & hydrologic patterns?			
Ooes the plan address possible issues such as ooding, soil erosion, or geotechnical hazards?			
Ooes the plan encourage the reduction of hard urfaces in order to assist with storm water nanagement?

Does the plan follow the Province's "Best Management Practises"?

Is it accessible via all modes of transport, including walking, cycling & public transport?

Does it demonstrate how the proposed development will result in investment in the area's strengths, skills & research capacities?
