In response to the rising costs of market housing and lack of affordable rental stock, the City of Vernon formed an Affordable Housing Committee in 2006. Over the past four years, the committee has been very active and has succeeded in facilitating the creation of an Attainable Housing Strategy and overseeing its implementation. Last year, the committee sponsored a newspaper insert with information on affordable housing and an overview of projects in the Vernon area. As a follow up to these initiatives, the group identified the need for an interactive and educational housing forum. As a result of the ACT grant, the committee was successful in hosting a forum on April 15, 2010. The evening event had two components; an open house with interactive booths and a speaker series on specific topics related to affordable housing. The event was viewed as a success due to the number of participants and the positive feedback received from the evaluation surveys.

		Housing covenants are relatively new to the City of Vernon. Dale provided a sample of a housing covenant and explained when and how this affordable housing tool is implemented. Dale also covered information on secondary suites and how they are registered and approved in the City of Vernon.
6:00 pm	Celina Owen has been with the Real Estate Foundation since 1998. As Manager of Communications & Administration, she plays a key role in internal and external communications and grant review.	Real Estate Foundation: The Real Estate Foundation supports many innovative projects, including research that pertains to land use and real estate policies and practices in BC and the construction of affordable housing. Celina provided an overview of the real estate foundation grant policies and showcase projects that have been funded by the Foundation.

Part of her role is to help coordinate community efforts to increase the number of affordable units in Greater Vernon.	Working Together: Non-profits and Developers Annette outlined the strengths provided by partnerships between non-profits and developers and highlighted models from other communities that could be adapted in Vernon.
7:30 pm	Rob Kjarsgaard Rob is the Administrator for Trades and Apprenticeship for Okanagan College in Vernon.	Okanagan College - Residential Construction Program Rob described the Residential Construction program and featured some projects that have been built in partnership with the program. He also disucessed how to partner with the program to build housing projects for not-for-profits in the Okanagan.
7:45 pm	Myles Gregory BC Hydro Power Smart	Myles Gregory is a Power Smart Specialist based in the Interior whose focus is to make it easier to utilize Power Smart programs and embrace conservation. He outlined some basics on conservation decisions during the construction process as well as what support is out there for developers and residents.

PARTICIPANTS

Approximately 150 people took part in the housing forum. The breakdown is as follows:

Speakers/Booth Operators	There were 42 people who participated as either speakers or booth operators. One organization had six tenants take part in their booth presentation. Many of the agencies and businesses took advantage of the networking opportunity the forum provided.
Participants	Almost 100 people signed in at the reception desk. Of those who indicated, 22 people were from the business sector, 30 from the non profit sector and 38 from the general community. Not everyone signed in at the reception desk or marked which sector of the community they represented.
Event Organizers	Eight members of the Affordable Housing Committee took part in organizing the event and overseeing the activities and speakers for the evening.
